

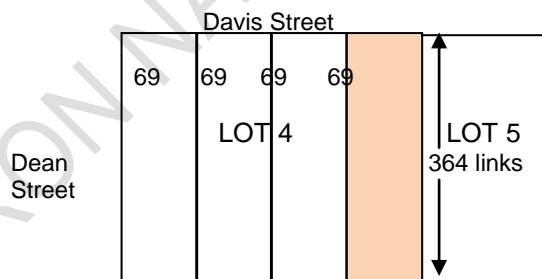
36 DAVIS STREET - PILL HOUSE LOT 4 SECTION 3 – CROWN GRANT 225

The original part of this stone house was built in the early part of 1887 by **Dennis BUCKLEY**, a local contractor who built quite a few houses in Stanley. The house was named Pill House by **William BOUND** who was born in Pill, Somerset, England and had come to the Falkland Islands as a young man on board the *Allen Gardiner*.

On 19 April 1875 Crown Grant 225 being Lot 4 in Section 3 containing one acre was issued to **William MARTIN** for £12 being bounded on the west by Dean Street and on the north by Davis Street. [CG 225]

On 11 December 1886 **William MARTIN**, labourer of Stanley, granted to **Dennis BUCKLEY**, contractor of Stanley, "*All that parcel of land in the Falkland Islands situate in Stanley being the Eastern quarter of special suburban allotment No 4 Section 3 and containing one quarter (¼) of any acre. Bounded on the North by Crown Land 69 links. On the South by Crown Land 69 links. On the East by Crown Land 370 links and on the West by land in the holding of Wm Martin 370 links*" for £25. On 10 June 1887 **Dennis BUCKLEY**, contractor of Stanley, granted to **William BOUND**, licensed victualler of Stanley, "*All that parcel of land in the Falkland Islands, situate in Stanley, being the Eastern quarter of special suburban allotment No 4, Section 3 & containing one quarter (¼) of an acre. Bounded on the North by Crown Land sixty nine (69) links, on the South by Crown Land sixty nine (69) links, on the East by Crown Land three hundred & seventy links (370) and on the West by land in the holding of William Martin three hundred and seventy (370) links; together with all buildings and erections whatsoever thereon*" for £303. In 1891, for tax purposes, the house was valued at £24. [FI Gazette]

On 4 November 1896 **William BOUND**, licensed victualler of Stanley, granted to **Jose Fiallio FARIAS** of Stanley, "*All that parcel of land in the Falkland Islands, situate in Stanley being the Eastern quarter of special suburban allotment No 4 Section 3 and containing one quarter ¼ of an acre Bounded on the North by Crown Land sixty nine (69) links on the South by Crown Land sixty nine (69) links on the East by Crown Land three hundred and seventy links (370) and on the West by land in the holding of William Martin three hundred and seventy (370) links together with all buildings and erections whatsoever thereon*" for £380. On 22 November 1922 George Isaac TURNER executor and trustee of **Estate late Jose Fialho FAREAS** granted to **Alice Maud STEVENSEN** of Stanley, "*All that parcel of land in Stanley being the Eastern quarter of special suburban allotment No 4 Section 3 and containing (¼) of an acre bounded on the North by Crown Land sixty nine links on the South by Crown Land sixty nine links, on the East by Crown Land three hundred and seventy links and on the West by land in the holding of R J Allen, three hundred and seventy links, together with all buildings and erections thereon*" for £175. [BUG-REG-9; 98] - 36 Davis Street

On 25 November 1922 **Alice Maud STEVENSEN** of Stanley granted to **Fanny Eliza SKILLING** of Stanley, "**All that parcel of land in Stanley being the Eastern quarter of special suburban allotment No 4 Section 3 and containing ($\frac{1}{4}$) of an acre bounded on the North by Crown Land sixty nine links on the South by Crown Land sixty nine links, on the East by Crown Land three hundred and seventy links and on the West by land in the holding of R J Allen, three hundred and seventy links, together with all buildings and erections thereon**" for £350. On 21 December 1943 William J HUTCHINSON administrator to **Estate Fanny Eliza SKILLING** of Stanley granted to **John SKILLING** of Stanley, "**ALL that parcel of Land situate in the town of Stanley being the Eastern quarter of Special Suburban Allotment No 4 Section 3, and containing $\frac{1}{4}$ of an acre bounded on the North by Crown Land sixty nine links, South by Crown Land sixty nine links, east by Lot 5 Three hundred and seventy links, West by land now in possession of Mr R Morrison three hundred and seventy links, together with all buildings and erections thereon**" for one shilling.
