

MEMORANDUM FOR THE INFORMATION OF
EXECUTIVE AND LEGISLATIVE COUNCILS.

At one of the meetings in May of this year the question was asked whether a "No Claims Bonus" on premia for Aircraft passenger insurance could be obtained. The Crown Agents were asked to inquire and the following is their reply.

" The insurers have stated with regret that they are not able to allow a No Claims Bonus. In fact, it has never been the market practice generally to allow No Claims Bonus on Personal Accident policies. The premiums are very low in comparison to the total amount at risk and several years premium would be required to offset a claim for only one person.

Furthermore, as you are aware, some time ago we negotiated for you a special discount of 10% on the premia, a discount which is not generally deducted."



28. INSURANCE OF PASSENGERS CARRIED BY FIGAS

It was noted that some misunderstanding existed regarding Government's liability for the insurance of passengers travelling by the Falkland Islands Government Air Service. Council advised that a suitable announcement be made explaining the position clearly to the Public.

Notes on
Passenger Insurance : F.I.G.A.S.

The limited liability insurance of \$6,000 per passenger carried by F.I.G.A.S. (i.e. Government) is maintained by an annual payment of premium through the Crown Agents. The annual amount involved is £

2. Passengers are in error if they believe that they or their representatives will automatically receive \$6,000 in the event of an accident. The amount which would be received would depend on the degree of injury, the status and earning capacity of the person injured/killed, etc. (For example, payment in respect of death in an accident of the breadwinner of a family could be expected to be higher than in respect of the death of the youngest child of a family of seven consisting of mother, father and five children; while payment in respect of death in an accident of the only child of a couple where the wife could not again have children might be expected to be higher than in the case of the death of the youngest child in a family of seven).

3. The foregoing relates to the carriers liability/responsibility. Passengers are at liberty to take out their own personal flight insurance. Where this is done, it is at present done by payment to F.I.G.A.S. which is in fact acting as agent for an insurance company. Passengers' payments for this kind of insurance are accounted for by the Treasury to the insurance company in arrears: but the Treasury makes notional payments in advance to the insurance company to ensure that, if an accident occurs and claims are made, insurance policies have in fact been paid for.

4. The type of insurance referred to in paragraph 3 is the personal concern of the passengers, not of government which already

- (a) operates the F.I.G.A.S;
- (b) pays the premiums in respect of the limited liability insurance.

It is assumed that this situation has arisen partly as a matter of chance and partly as a matter of convenience. However, although it would no doubt be both a tidy and a desirable solution if passengers' personal flight insurance could be handled entirely by the private sector it seems unlikely that this result can be achieved in local circumstances and that there is no choice but to continue with the present system.

5. In these circumstances, where Government is in fact fulfilling a function which in other circumstances would be carried out by the private sector, it is justifiable and, it is believed, would be understandable if the function became a revenue-earning one. Operated by the private sector the locally accruing revenue would be in the form of agent's commission: in the situation where Government has not hitherto received commission from the insurance company it may be necessary for the revenue-earning aspect to be covered by a specific fee, thus slightly raising the amount paid by the passenger per \$1,000 of insurance.

Passengers: Personal Flight Insurance

You will recall recent discussions on the above-named subject. Since then, as can be seen from the attached notes, I have taken my thoughts on the matter slightly further.

I suggest that the attached notes be used as the basis for further discussion of this matter and perhaps that we meet in my office at 2:30 p.m. on Monday, 9th June, to go further into the matter.



F.I.G.A.S. PASSENGER FLIGHT INSURANCE (Memo 48/69)

The Colonial Secretary explained that the position regarding passenger flight insurance by the Falkland Islands Government Air Service was complicated and that enquiries were being made to ascertain whether the insurance company would continue accepting the reduced number of premiums that were currently being collected as a result of Government withdrawing the compulsory requirement for each passenger to take out a personal insurance on every flight. At the moment the position was too complicated to lend itself to a public announcement or Gazette notice and Council agreed that the matter be held in abeyance until the position clarified when it should be clearly explained by public notice and amplified by a radio programme in which specially prepared questions could be asked with someone providing the answers.



PASSENGER FLIGHT INSURANCE

We refer to your above letter with December quarter 1970 declaration attached and advise that the Insurers are prepared to renew the policy for a further period of 12 months with effect from 1 July 1971 on the same terms and conditions as before except that they require a minimum and deposit premium of £25.

2 Representations have been made by us to the Insurers with regard to this required deposit premium but it is regretted that we were unable to achieve an improvement on this requirement. In the light of recent declarations giving NIL returns you may wish to consider whether this insurance should continue on the present basis.

3 It is suggested that it might be preferable for Flight Cover to be given on separate declarations with each Insurance Premium to be calculated according to the proportionate risk involved but in this respect it would be necessary for full details to be notified to us in advance in order that cover could be obtained and a Policy issued accordingly. This alternative is suggested if the number of risks is likely to be small and before taking any further action we await your reply on this matter.

My opinion is that this type of insurance is no longer essential although some passengers may feel that it is desirable.

2/ Although the deposit (minimum) premium is only £25 my view is that the time has come for Govt to discontinue the insurance review.

3/ Passengers are covered by the Guadalupean Convention (I think that is the title) and there is good provision under this convention for people who would be injured or handicapped as the result of a flying accident.

Passenger Flight Insurance


Memorandum by the Colonial Treasurer

Council's attention is invited to Minute No. 20 of the meeting 15th/17th July, 1969. The position then was that the reaction of the flying public to the changed circumstances in which the carrier was required to provide insurance cover of up to £6000 per passenger for damage sustained as the result of a flying accident, had yet to be assessed, and that the facilities for private additional insurance should continue.

2. The underwriters accepted that there would be greatly reduced use of this additional facility and were prepared to renew the policy for a period of 12 months on the payment of a minimum premium of £25. This sum has been paid from revenue.

3. The question of whether the policy should be renewed for a further period will need to be decided shortly. It seems that the flying public has no further interest in extra-insurance facilities there having been no case of private insurance since February 1971.

4. In these circumstances it is suggested that the continuation of the policy, even for the low figure of £25, is no longer desired by the flying public and Council is invited to advise that it should not be renewed next year.
