

ERECTION OF MISSEN HUTS (UAR PURPOSES.)

Subject to the approval of the Falkland Islands Government, the Admiralty propose to erect three Nissen Huts on the foreshore east of the Falkland Islands Company's East Jetty (vide accompanying sketch). These huts will be built on brick piles and floored with timber. They will take the place of the First and Last for storage of Haval Stores.
