

X хх x xI wish, however, to Χ х x put on record that O.C. Defence Force approached me recently with a proposal that the site should be reserved for a drill shed. If it is found possible later to erect a drill shea there will certainly be a minature range and Mr. Neave advised me that unless heavy expenditure were incurred a range would not be safe on land immediately to South of the house which he occupies: there would be danger to houses on rising ground to south of the site. A more suitable site for drill shed and range can be found either in dairy paddock or Magazine Valley. It should in any case be at some distance from dwelling houses: when there was a range on site of old Assembly Rooms it was a nuisance to neighbouring houses.
