GOVERNMENT SAVINGS BANK (Imperial Troops)

Suggested method of dealing with a new department of the Government Savings Bank to be called "G.S.B. (Imperial Troops)" which will receive monies on Deposit for the Imperial Troops quartered at Stanley.

(1) This new account will be kept separate from the present Savings Bank account, but will form part of Deposits a/c., with a special accounts current ledger.

(2) All Deposits made by troops will be collected in the first instance by the Paymaster's Department, and the lump sum passed to the Treasury, with full details embodied in the attached form, and accompanied by the respective Bank Books. A receipt will be given the Paymaster for each lump payment, but the Depositor will not receive a separate receipt, but the amount appearing in his Bank Book will constitute a receipt as far as he is concerned.

(3) Withdrawals will be restricted as far as possible and can only be made under the verifying signature of the Army Paymaster.

(4) The minimum deposit will be ten shillings and all deposits should, as far as possible be confined to round figures in order to simplify the work.


(5) Interest at  $2\frac{1}{2}\%$  per annum will be credited in the same manner as is employed with the existing Bank.

(6) A special Bank Book with special marks to distinguish it from the rest will be used.

(7) On the withdrawal of the troops all amounts deposited will be repayable in the United Kingdom, to be met from the accumulated funds guaranteeing these deposits.
