IN THE NAME of His Majesty GEORGE VI., by the Grace of God of Great Britain, Ireland and the British Dominions beyond the Seas, King, Defender of the Faith, Emperor of India, &c., &c., &c.

WHEREAS a state of War exists between His Majesty the King on the one hand, and Germany , on the other;

AND WHEREAS it is necessary to specify the Articles which it is intended to treat as Contraband of War;

NOW, THEREFORE, I Sir Herbert Herniker Heaton, K.C.M.G., Governor and Commander-in-Chief in and over the Colon hereby declare, the Falkland Islands and its Dependencies the United the Livecutive Council, that during the continuance of the War, or until further notice, the articles enumerated in Schedule I hereto will be treated as Absolute Contraband, and the articles enumerated in Schedule II hereto will be treated as Conditional Contraband.
