No. 265. I understand from unofficial sources that the Norwegian Government required all shares in Norwegian companies to be specially registered by the 9th September 1945 on pain of confiscation.

2. Several people here own Norwegian whaling shares and they should be protected. Grateful if you could (a) confirm the above and advise me and (b) ask the Norwegian Government to suspend confiscation pending the receipt of applications for registration from here.

3. On receipt of your reply I would collect the names of shareholders, particulars of shares held, and applications for registration and telegraph through you.
