This appears to be a duplication of an item for the same amount shown on page 3 of your Account dated 9th September. If so, please pass credit for the equivalent of eight shillings and eleven pence (8/11d) Sterling.
- 2) Page 2 - SHELL (URUGUAY) LTD. - Expenses Empty Drums.
Shell invoice No. PCC 684 of 24th Sept. - We cannot agree the number of drums shown as discharged from 'FITZROY' 2/3.2.54. The 150 'AVGAS' drums appear in order, but no drums marked 'CDC' were shipped that voyage, although per 'MARTIN S' in January we shipped 203 'CDC' (these are shown on this invoice). According to our records a total of 793 drums (including the 'AVGAS') were shipped, and Shell invoice shows 973 drums 'FIO' discharged. Possibly these figures have become confused. We shall be glad if you will please take this up with Messrs Shell Ltd.

Shell invoice No. PCC 737 of 11th Oct. - Please advise us the dates of the shipments concerned.
