As you are aware, the Inter-Insular Communication and Service Contract between the Government and this Company expires on the 31st proximo.

Owing to the enormous advances in the costs of all materials, stores and wages in connection with shipping, I regret that the Managers cannot see their way to renew the contract unless the subsidy is greatly increased. Perhaps His Excellency the Administrator will be good enough to let me know whether the Government is prepared to open negotiations on the subject.


Sir,


