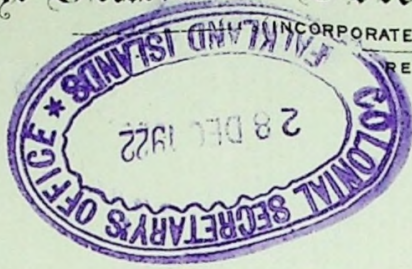

Sir.

On my return from the Coast by the "S.S. Falkland", I brought with me two fox cubs. being unaware that there were any restrictions against the importing of same to the Colony.

These animals were brought over solely as pets and are quite harmless.

I should esteem it a favour if you would advise me, what is to be done in the matter. as they are at present on board the "Falkland" I should there be no chance of them being allowed to land I suppose I must give instructions for them to be killed, which I should be loth to do as they are only cubs about 1 month old & as I have said before quite harmless.

Sir,

I am directed by the Governor to acknowledge the receipt of your letter of the 22nd of December informing me that you had brought with you, in the s.s. "Falkland", two fox cubs as pets. Broaches were committed of the Live Stock Regulations of 1914 and by Proclamation No. 2 of 1921, there is an absolute prohibition of the import of those animals.

2. I am to convey to you His Excellency's regret that there is no power under the law to allow of the landing of the cubs.
