Subject :- Meteorological equipment at West Indian Lighthouses.

Sir.

I am commanded by the Air Council to refer to your letter of 19th January last addressed to the Director, Meteorological Office, stating that the Inspector of the Bahamas Lighthouses had requisitioned 4 Meteorological Registers and 4 Meteorological Thermometers for use at the Sombrero Lighthouse, West Indies, and asking if instructions could be given for these articles to be forwarded to the Inspector. As already notified the registers and thermometers have been issued. It is now desired to raise the question as to the responsibility for the upkeep of the meteorological equipment at certain West Indian Lighthouse Stations.

Meteorological registers are received regularly from the following:-

Sombrero
Cay Lobos
Wat ling Island
Inagua
Double Headed Shot
Abaco

The equipment at each station normally consists of the following:

1 mercurial barometer

3 ordinary thermometers

1 marine screen in which thermometers are exposed

1 raingauge

1 rain measure

In the case of Sombrero there is an anemometer in addition.

A recent report from the Inspector of Lighthouses shows that the equipment at several of the stations is deficient or unserviceable and the question arises as to whether the deficiencies should be made good, and if so at whose expense.

The most important item of equipment is of course the mercurial barometer. From the available records it would appear that the barometers at Inagua and Abaco belong to the Air Ministry, while those at Sombrero, Cay Lobos, Watling Island and Double Headed Shot were issued from the Meteorological Office, which is now a department of the Air Ministry, to the stations on repayment by the Board of Trade, at various dates prior to 1896.

The remaining equipment at Cay Lobos, Inagua, Double Headed Shot and Abaco also belongs to the Air Ministry. There is no information as to the ownership of the remaining equipment at Sombrero and Watling Island.

It would be of advantage if the responsibility for the maintenance of the whole of the meteorological equipment were undertaken either by the Board of Trade or by the Air Ministry, and if the present somewhat unsatisfactory arrangement could be terminated.

In view of the fact that the lighthouse service is administered by the Board of Trade there would be many advantages if the Board would undertake the responsibility. On the other hand it may be considered that as the observations are forwarded to and utilised by the Air Ministry the Ministry should maintain the equipment.

I am to request that you will indicate the views of the Board in the matter.

Sir.

I am directed by the Board of Trade to refer to your letter of the 16th October last (320855/22 M.O.4) on the subject of the maintenance of the meteorological equipment at certain of the light-stations in the Imperial Lighthouse Service, Bahamas.

In reply, I am to state, for the information of the Air Council, that the Board understand from the Corporation of Trinity House that the Air Ministry maintain meteorological equipment at certain Light Stations in this Country and pay a small remuneration to the lightkeepers in recognition of their services in connection with the recording of observations, etc. The Board are of opinion that the expense of maintaining the equipment at similar stations abroad should not be charged to the General Lighthouse Fund as it is not required for lighthouse purposes, and they assume that, in these circumstances, the Air Ministry will accept full responsibility for the maintenance and renewal of the equipment at the West Indian Stations, and also at Cape Pembroke Station, Falkland Islands, as in the case of similar equipment at lighthouses in this country.

I am to add that if the Air Council concur in this opinion the Board propose to inform their Inspector at Nassau, and the Colonial Secretary, Falkland Islands, that all indents for stores and all records and registers kept at the lightstations in question should in future be sent direct to the Meteorological Department, Air Ministry.

Subject: - Meteorological Equipment at West Indian Lighthouses.

Sir,

I am commanded by the Air Council to acknowledge the receipt of your letter of the 2nd December on the above subject, and note that it is the view of the Board of Trade that the Air Ministry should accept full responsibility for the maintenance and renewal of the equipment at the West Indian Stations and also at Cape Pembroke Station, Falkland Islands.

The Air Council see no objection to this proposal and have accordingly directed that any such equipment at those stations which is not already on charge, should be brought on charge forthwith.

It is noted that indents for stores and all records and registers kept at the Light Stations will in future be sent direct to the Meteorological Office, Air Ministry.
