





Transformers are available so that transmission would be at 10,000 volts. These two methods would require no additional upkeep expenditure as plant at W/T Station will be capable of the extra load and must run in any case.

B. Separate generators at D/F site.

It is suggested that in this case generators should be D.C. type. Power of approx. 5 KW is considered sufficient and could conveniently be driven by a Petter engine atomic type diesel of 6 BHP. This type of engine uses either gas oil or light Diesel oil at a maximum of 9 gallons of fuel for 24 hours.

Cost of Engine, cooling tank, generator and switchboard is £ 126. Thus a twin set should not exceed £252. Gas oil at present costs (including freight) 1/5d per gallon. Diesel oil 2/3d per gal. Gas oil is now difficult to obtain.

Yearly fuel expenditure including lubricating oil should not exceed

£400.

Prices quoted are actual catalogue prices and should be cheaper to Government. Distances have only been estimated and would have to be more accurate to estimate true cable lengths required: consider--able overestimate has be n allowed.

ELECTRICAL SUPPLY TO MAVAL BASE.

The Admiralty feel that the present cost of supply of electric power for Naval purposes is too high and are proposing to instal their own machinery for these purposes.

2. I feel that if a reasonable reduction is possible, this step could be obviated, and personally I consider this would be far more satisfactory from the point of view of simplicity and effeciency.

3. At the present moment the cost of supply is in the neighbourhood of £1000 p.a. - a very large figure - and I was certainly of the opinion, when the present arrangement for 24 hour supply was made, that this included all supply for Naval purposes; I have received other accounts which, allowing for differences between summer and winter, make up a further  $2200 p_{a}^{+}a$ . approximately.

4. I should be grateful if a revision of costs could now be made so that I can submit a more favourable figure to their Lordships.


