The implication in paragraph I is correct.

- 2. The reservoir in question received its supply from surface water off the Common via Fitzroy Road.
- The Improvement Works scheme the water from the Common has been diverted and now flows to the sea East and West of the town, and not into the town as previously existed. This work necessitated cutting off a certain amount of water from the Company's reservoir. It would, however, have received more water in compensation for this deflection when the scheme was further advanced, as it is proposed to regrade Fitzroy Road so as to discharge a portion of the water to the Company's reservoir.
- 4. I have been into the question with the Manager of Messrs The Falkland Islands Co., and it was agreed that the difficulty could be overcome without being prejudicial to the scheme by inserting a bye-pass into the sump at Hebe Street.
- 5. I had this work done on the 25th January, 1927 so there should be no further question of supply for this reservoir.

Sir.

I beg to advise you that a serious inconvenience to us and interference with the coasting trade is likely to be occasioned through surface water, which formerly flowed into our underground reservoir, being deflected to other channels.

- 2. Several years ago this Company, at a certain amount of expense, excavated a reservoir at the head of our East jetty for the purpose of supplying our coasting vessel with boiler water, other storage tanks or reservoirs being inconvenient or containing insufficient supplies. I may add that other steam vessels calling at this port often call on us for water, and even with our reservoir full, in times of drought the supplies are inadequate.
- 3. In conclusion I beg to request that the matter be laid before the Executive Engineer of the Stanley Improvement Scheme who is in a position to advise as to the best method of diverting more of the surface water to our reservoir than it receives at present. The matter is really an urgent one as, if we have another drought such as has been experienced during recent years, boiler water will be unobtainable and the coasting trade at a standstill.
